# October Board Meeting

October 6, 2024

#### 1. Role Call-

- 2. Spring 2025 Registration
  - a. \$5 raise in regular reg to help costs that have gone up (chalk, balls, lights, uniforms, etc.)
  - b. 6u- \$130, \$185, \$220
  - c. 8u-16u- \$190, \$245, \$300
  - d. The board had an online vote and all approved prices for Spring 2025 (see above).
  - e. Spring Team formation-Buddy requests? Coach Requests? Which format do we want to use?
    - Jen discussed how Pony addresses Coach's kids being ranked and the Coach not getting that round's pick to prevent stacking.
    - ii. Amy noted maybe we have the Coach and Manager's kids on the team along with 1 pick each for a 4-player max stack.
    - iii. Holli addressed what Rocklin does to keep teams fair with coach's kids being the first picks and then moving on to evaluated pitchers and

- catchers next in the draft. We already spread out pitchers in the draft, as most coaches pick pitchers first anyway, and do not feel the need to rank all pitchers ahead of time beyond the coaches/board evaluating them at evaluations.

Board made a unanimous decision to return to the way we did it several years back, after hearing many complaints about teams being stacked because of buddy requests and are going with the following: 8u-16u player eval and draft. Coach's kids are rounds 1 and 2. Managers will be advised to pick a Pitcher and catcher early in the draft and the Board will intervene if needed to spread out P/C. No buddy requests. No coach requests. Only a Board selected Manager and 1 coach may pair up before the draft.
